The Board of Directors of **Gagan Gases Limited**

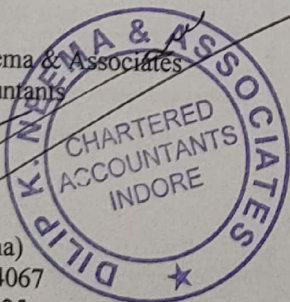
1.
